

TERMS & CONDITIONS

- 1) The Promoters are Rainbow's End Theme Park Limited, 2 Clist Crescent, Manukau, Auckland.
- 2) Employees of the Promoter or anyone else connected with the competition or helping to set up the competition shall not be permitted to enter the competition.
- 3) The prize pool is valued at \$4,215.00 (plus exclusive experiences not available for purchase).
 - a) Up to 30 Rainbow's End Superpass Riding Passes for the Classroom of the winner winning classroom.
 - b) Up to 20 Rainbow's End Companion Superpass Riding passes
 - d) 1x Private Area to be utilised as a base for the day
 - e) A "Pizza Party" consisting of 15 x assorted pizzas for lunch
 - f) Performance on Centre Stage of the winning Sea Shanty
 - g) VIP Ride on the NEW Pirate Ship
- 4) Superpasses give unlimited riding parkwide on the date of the booking, where height and age restrictions are met.

ENTRY CONDITIONS

- 7) To enter the competition, a supervising adult/teacher must record a video of the classroom performing a dance or acting in a play or other creative performance to the music of the NEW Rainbow's End Sea Shanty.
- 8) Closing date for entry will be 11.59pm Sunday 19th October 2025. After this date, no further entries to the competition will be permitted. No responsibility can be accepted for entries not received for whatever reason.
- 9) Rainbow's End staff will vote for the Top 5 entrants via a voting ceremony. The Top 5 entrants will be notified and their video upload to Rainbow's End social media (Facebook & Instagram) by Tues 21 Oct. The entrant with the most "likes" across facebook and Instagram (combined likes) by 11:59pm Mon 27 October will be announced the winner.
- 10) The rules of the competition and the prize for the winner are as follows:
 - For each entry the entrant/classroom/group receives 1 ticket into the draw. Each valid entry will be considered for shortlisting.
 - The entrant must complete an entry form (link to entry form will be supplied) and video to fun@rainbowsend.co.nz before the entrant closing date
 - Rainbow's End staff will reply via email to confirm entry to the competition.
- 11) The Promoter reserves the right to cancel or amend the competition and these terms and conditions without notice in the event of a catastrophe, Government mandated lockdown, act of God or any actual or anticipated breach of any applicable law or regulation or any other event outside of the Promoter's control.
- 12) Any changes to the competition will be notified to entrants as soon as possible by the Promoter.
- 13) No cash alternative to the prizes will be offered. The prizes are not transferable.
- 14) Valid for entry on one date to the park between October 31 – December 19th 2025 (excluding public and school holidays).
- 15) Group must arrive together and must book before arrival. A suitable adult representative from the school must contact fun@rainbowsend.co.nz to arrange the booking at least 7 days prior to proposed visit.
- 16) Not exchangeable for cash, and unused prize components will not be credited. The prizes are not transferable.
- 17) There will be no extensions to the prize redemption period.

- 19) The winner will receive confirmation that they have won via a phone call from Rainbow's End Theme Park (providing contact details have been supplied), once the competition has closed.
- 20) If the winner cannot be contacted or do does not claim the prize within 7 days of notification, we reserve the right to withdraw the prize from the winner and hand the prize to the second place contestant.
