## TERMS & CONDITIONS

- 1) The Promoters are Rainbow's End Theme Park Limited, 2 Clist Crescent, Manukau, Auckland.
- 2) Employees of the Promoter or anyone else connected with the competition or helping to set up the competition shall not be permitted to enter the competition.
- 3) There are 50 prizes in total. Each prize winner will receive 2 x Superpass tickets valued at \$75.90 each.
- 4) Superpasses give unlimited riding parkwide on the date of the booking, where height and age restrictions are met.

- 6) Closing date for entry will be 11.59pm Sunday 19th October 2025. After this date, no further entries to the competition will be permitted. No responsibility can be accepted for entries not received for whatever reason.
- 7) The winners will be randomly selected using a random generator.
- 8) You can enter more than once. Each stream on a new platform will give the entrant an entry into the competition.

# TERMS & CONDITIONS CONTINUED

- 10) Any changes to the competition will be notified to entrants as soon as possible by the Promoter.

- 12) Each double superpass is valid for entry for two people and must be booked in advance between the dates of 10 November to 31 March 2026.
- 13) The double superpass must be booked and used at the same time.
- 14) Not exchangeable for cash, and unused prize components will not be credited. The prizes are not transferable.
- 15) There will be no extensions to the prize redemption period.
